SCHOOL OPERATION Budget Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment and Approved Budget presentation for 2021-22. Enrollment update presented reflected a student count of 738 as of November 23rd. Of that total 552 students re-registered. Incoming students registered 186. Of that total 99 were incoming Kindergarten. The budget is based on student count of 665.

The Approved Budget for fiscal 2021-22 presented as of November 30th reflected total budgeted full year (FY) revenue is \$13.0 million. YTD recognized \$4.0 million. Total budgeted (FY) direct expenses \$9.9 million. Spending YTD \$4.1 million. Total budgeted (FY) indirect expense is \$3.1 million. Spending YTD \$1.5 million. On target for FY Spending.

The Approved Budget for fiscal 2021-22 presented: Enrollment budget presented 665. Budgeted full year (FY) revenue is \$13.0 million. Budgeted direct expenses \$9.9 million. Budgeted indirect expense \$3.1 million.

SAFETY COMMITTEE- November Report:

Drills (Fire, Bus, Lockdown, Evacuation)

- 1) Fire Drills: New York State (NYS) law requires all schools to perform **12 fire drills yearly. Eight of twelve must be completed by December**. Both sites have completed eight drills. Additional drills will be scheduled for the Spring.
- 2) Bus Drills: NYS Law requires **3 Bus Drills** for the School Year. The 1st Bus Drill was completed on September 17, 2021. The 2nd Bus Drill was completed on November 5, 2021. Remaining bus drill will be scheduled for Spring.
- 3) Lock Down Drills (Hold in Place): NYS Law requires that **lockdown drills** are performed. There will be 2 more drills performed this month following the Covid-19 guidelines. Principal's will decide what day the drill is scheduled. Will work to make sure each class have their keys in preparation for upcoming drill in January.
- 4) **Evacuation Drill:** Both sites are set to perform this drill in May 2022. Date is TBD. Building Concerns: NONE.

Health and safety continue to be a high priority. Daily building cleaning and sanitizing of high touch areas continues.
