# Middle School Report:

# **ACADEMICS:**

- ❖ Our school year started off well. We welcomed our students with bubbles of love on September 5<sup>th</sup>. Our new students reported that they are having a good experience.
- ❖ The TLAC professional development and the refresher PD on Restorative Practice had a great impact on the tone that was set by staff during the first two weeks of school. Teachers are incorporating many of the techniques within their daily instruction and as result, academics are being focused upon more.
- ❖ The administration of the first iReady diagnostic assessment took place on September 14<sup>th</sup> and 15<sup>th</sup>. In comparison to this time last year, we have a 3% increase in math and remained the same in reading thus far. Students who missed the assessment will have an opportunity to make up the assessment during the week of September 18.
- ❖ The data gathered from the iReady results and daily aggressive monitoring will be used to drive daily groups in both math and ELA.

We have incorporated cursive writing during students' lunch period. Students practice

- writing 1 to 2 letters each day thus far. This activity is supervised by our teacher assistants.
- ❖ To aid in multiplication proficiency, we plan on students practicing their times table each week. We will start with the 0- and 1-times tables. Then each week we will add another timetable. At the end of each month, we will quiz the students on what they have learned. We will focus on our fifth-grade students with the goal that by the time our fifth-grade students are eighth graders, all students will be proficient in their times table.
- ❖ Coaches and I will begin weekly walk throughs in math and ELA in October. Coaches will then meet with teachers individually to provide feedback on the observations.
- Our first half professional day will be on Thursday, September 28. The focus will be on be on IReady (Standards Mastery)
- ❖ Open House took place on September 11. We had a good showing. About 20 to 40 parents per grade level came to Open House.
- ❖ As a middle school, we have established 7 core values (Trust, Empathy, Authenticity, Respect, Being Present, Vulnerability, and Judgement-Free Zone). All classes engage in daily Restorative Circles and Mindfulness activities. This is done during homeroom from 8 am to 8:25 am. Discussions about our Core Values and this month's Character Trait (respect) take place when needed during instructional blocks.
- ❖ We will be starting back Saturday School to provide additional instructional support to our identified level 1s and 2s. Saturday School will begin on January 6<sup>th</sup> and will run through Saturday, May 4<sup>th</sup>. There will be a total of 13 Saturdays.

### ELA:

❖ In ELA, teachers have prepared engaging lessons that center around getting to know their students, developing relationships and skill enhancement. They have integrated the schoolwide core values into their routines and are embracing restorative practice. All ELA classrooms will dive into our EL Curriculum on September 18th.

5th Grade will begin Module 1 which focuses on the essential question "What are human rights and how can they be threatened?" They will read the novel "Esperanza Rising." They will also be introduced to the "UDHR" which is the Universal

- Declaration of Human Rights.
- ❖ 6th Grade begins their first module which focuses on the Essential Question: What is mythology and what is the value of studying mythology from other cultures? The accompanying novel is "Percy Jackson" and they will also discuss The Hero's Journey as relates to the main character.
- ❖ 7th Grade begins their first module with "A Long Walk to Water" novel which focuses on The Lost Children of Sudan and their story.
- \* 8th Grade begins their module that focuses on the Essential Question: Why do we see evidence of myths and traditional stories in modern narratives? They will read "Summer of the Mariposas."
- ❖ This week the ELA Team is assessing students with Writing and Iready Benchmarks.
- ❖ In order to increase scores on the ELA State Assessment we are incorporating aggressive monitoring, small group targeted instruction and explicit vocabulary instruction. We have segmented forty minutes of the ELA block to support RTI, SpEd and ENL pull out services as well as the targeted instruction.

#### Math:

❖ 5th Grade Math is currently working on Unit 1: Numbers and Operations in Base Ten Textbook Chapter 1: Lesson 1: Place Value through millions. 6th Grade Math is currently working on writing rates as unit rates. 7th Grade Math is currently working on Textbook Chapter 1: Lesson 4: Proportional and Non-Proportional Relationships. 8th Grade Math is currently working on Textbook Chapter 1: Lesson 3: Multiply and divide Monomials.

# **Special Education:**

- ❖ Special Education services have begun as of 9/11/23.
- Students are receiving resource room services as well as speech, counseling, physical therapy & occupational therapy.
- We are working more closely with our providers to ensure the academic and socialemotional success of our students.

All teachers have received and reviewed their students' IEP and are aware of how the IEPs are to be implemented.

- ❖ We currently have 20 Elementary students with IEPs and 27 middles school students that have IEPs.
- ❖ A few students are currently not receiving services to date due to outside agency shortages and scheduling conflicts. Mrs. Johnson is working with the local district and agencies to get services started as soon as possible.

# RTI

- ❖ RTI Teachers are wrapping up the first round of assessments to determine appropriate levels for our at-risk population. Based on student levels they will be placed in an RTI group of 5 or less students
- ❖ In Math we are using the Number Worlds curriculum for grade 4-8
- ❖ In Reading we are using both LLI & Achieve 3000,
- ❖ The intervention curriculums we are using are research based and have yielded great results over the past few years, with many students graduating from the RTI program altogether. Students who remained in RTI showed wonderful improvement.
- ❖ The Goal of RTI has and will continue to be to close the achievement gap, when little to no success has been achieved, we will refer students to the CST Team and if student still shows minimal progress, a special education evaluation will be the next step, with the consent of the child's parent.

### **ENL Report:**

❖ The ENL department is looking forward to a productive and successful year with our students. In grade 5, 1 student increased in proficiency level (transitioning to expanding). In grade 6, 1 student tested out (commanding)and 4 students increased in proficiency level (all from transitioning to expanding). In grade 7, two students increased in proficiency level (one emerging to transitioning and the other transitioning to expanding) In grade 8, one student increased in proficiency level (emerging to expanding).

During the month of September, the ENL department will be administering the NYSITELL which identifies potential ENL students whose home language is a language other than English as specified on the home language survey. We continue to

contact new students' previous school districts to obtain pertinent ENL information for placement at RCA. We are also awaiting the ELA state test scores to find out if any students achieved a 3 on the state test. If ENL students earn a 3 on the state test and a proficiency level of Expanding on the NYSESLAT, they will be able to test out of our program.

# **Guidance Counselor:**

- ❖ September 11 Parents received Middle School Guidance introductory letters with program information, contact information and Remind codes during open house. This information will also be sent to all parents electronically.
- ❖ September 11 8<sup>th</sup> Grade parents received a packet of information for Long Island Catholic High Schools during open house which included introductory letter, list of Long Island Catholic Schools, schedule of all open house events, information on the TACHS entrance exam. This information will also be sent to all parents electronically.
- ❖ High School Night will be planned for November (Date TBD)
- ❖ The peer mediation team will be back up and running this month. Students will meet to review procedures, informational posters will be displayed in the hallways, an email will be sent to staff and mediating will begin.

### **Discipline Report:**

- ❖ Dean attended two Professional Development weeks of Restorative Circles Training over the summer which focused on implementing restorative questioning and values into daily routines in every classroom. Modeling will be emulated in teachers' classrooms.
- ❖ Teachers are responsible for creating, discussing, and posting core values in classrooms that can be added to as the school academic year progresses.
- \* Restorative questioning must be reflected on all lesson plans including specials.
- Moments of Mindfulness meditation are scheduled every morning and afternoon to create a calm and community environment.
- Meditation Room has been established as an extra support room for those students who need to reflect on behaviors that are Tier 1 behaviors. Multiple meditation room students will then move to Lunch Detention or other consequences.
- ❖ Deans' professional goals are to become additionally coached in Restorative Practices.
- ❖ Book utilized for Restorative Circles: *Circle Forward: Building a Restorative School Community* by Carolyn Boyes-Watson.
- ❖ Additional Intervention Resource: *Pre-Referral Intervention Manual* (4<sup>th</sup> edition) by Stephen McCarney. The book is a manual that is comprised of learning and behavioral problems in the educational environment with solutions for today's students. Staff can borrow the books as needed.
- Restorative Justice Practices remains reflected in Lesson Plans as a connective tool for academic and social emotional learning.
- Ms. DiTucci, Elementary School Dean of Students, and I meet via Zoom/in person every Wednesday morning to discuss various set agenda items such as parent communications, food drives, restorative justices visualized within the classrooms etc. Our latest discussion has been how to prepare the staff with PDs throughout the school year on SEL, Restorative Circles, and Dean's List.

A second professional goal of the Dean is to coach teachers within the classroom setting regarding discipline structure. This task has already started with the seventh-grade team. Several visits have been made with input that will be discussed with the teachers, Ms. Roberts, and team coaches. All information will be documented for resourcing purposes.

- ❖ Teachers/TA's utilize Deans' List to record Parent Communication via phone, email, or text message. Administration strongly encourages phone communication. instead of text or email. An August PD was given on the usage of Dean's List.
- ❖ The Uniform Policy is being enforced daily with several checks throughout the morning. Calls are made when an infraction is found.
- ❖ The Community Service Program will begin with the 8th grade class. Many students will work with teachers in school and parents have reached out to me regarding outside projects. There will be a celebration ceremony for those who have completed the 20 hours at the June 2023 Graduation Ceremony.
- Communication with administration is paramount. Dean communicates with Principal several times a day to discuss/review and creates strategies to make the middle school a safe and academically successful environment.
