Middle School Report:

ACADEMICS:

- ❖ About 85% of the school population took the NYS ELA assessment on March 29th, 30th, and during the makeup week (March 31 to April 7). The ELA team are now assisting the math team by helping students use their ELA skills to understand and to solve word problems. In math, teachers are teaching and reviewing the major skills that students need to demonstrate proficiency on for the NYS math assessment as well as to be prepared for the next grade level.
- NYS Math assessment April 26th and April 27th
- NYS Science performance assessment June 1st and the NYS Science written Assessment June 6th.
- At Risk letters were sent home and parents were contacted about academic concerns and strategies for improvement.
- ❖ Discussions for summer school have begun. It will be made mandatory for students who are failing ELA and/or math. The program will be geared to filling in some of the academic gaps of the students.
- We will be hosting a math competition in May. The date still needs to be finalized.
- We are in the process of finalizing our plans for Graduation, Career Day, and the Spring Cultural Day Festival.
- ❖ The Student Government have been meeting on a weekly basis. The group is currently fundraising to be able to host future events for the student body. They are planning to have a basketball competition.
- In ELA, 5th Grade is concluding their work with "The Most Beautiful Roof in the World" with a performance task of creating a rain forest adventure E-book based on information gathered throughout the current unit. In mid- May, they will begin their final Module for the school year which focuses on factors that contribute to the success of professional athletes as leaders of social change, beginning with Jackie Robinson. 6th Grade is currently focusing on Poetry which includes, different types of poetry, figurative language and determining theme and central ideas. This study will conclude with a poetry café to showcase the student's poetry, date to be determined. 7th Grade continues reading the classic play "Pygmalion" and are focused on character analysis. 8th Grade is currently studying the U.S. civil rights movement, focusing particularly on The Little Rock Nine. They are currently reading "A Mighty Long Way" which is a riveting account of nine brave high school students and their families in a quest for quality desegregated public education. Grades 5, 6, 7 and 8 continue to focus on understanding informational text during small group instruction.

- Ms. Boney will work with the ELA team to create new small groups based on the most recent IReady data and assist 5, 6, and 7th grade teachers in their preparation for their upcoming units through backwards planning.
- ❖ In Math, 5th Grade is currently working on Expressions and Patterns focusing on Numerical Expressions and Order of Operations. 6th Grade is currently working on Area component of Geometry. 7th Grade is currently working on Probability and Statistics focusing on Simple Probability and Experimental and Theoretical Probability. 8th Grade is currently working on Exponents and Exponential Functions. Algebra 1 is currently working on Exponential Functions and Simplifying Radical Expressions.
- Second round of Teacher Observations have been completed and their observations have been submitted.

❖ Academic Goals:

- ✓ In the area of mathematics, it is our goal to have a 20% growth of students performing at levels 3 and 4 among all grade levels. Currently, 49% of our students are at level 3s and 4s. This is 8% higher than last year. With continued intervention, I believe that we will attain this goal by the end of the academic school year.
- ✓ In the area of ELA, our new goal is to have at least 40% of students performing at levels 3 and 4 by the next Benchmark assessment for writing. Currently, we are at 34% of 3s and 4s in writing. With continued explicit instruction, intervention, and opportunities to write, we believe that scholars will make continued improvements.
- Stock Market Game is well on its way. The students had an 12.32% Gain. The game will run until February. We are within the top 50%.
- D.E.A.R is a success. Students every day are reading from 8 am to 8:20 am. This is not only improving students' vocabulary and reading fluency, but also setting a more positive tone for the start of the day.
- Mr. Cesar will be working together with Mrs. Balunas and Mrs. Longo to organized our annual Art & Poetry Café.

RTI

- ❖ The second RTI cycle concluded on February 18th and cycle 3 commenced on February 28th.
- ❖ K students began receiving RTI services for Cycle 3 and will remain in intervention through the end of the school year
- 19 students in grades K-4 exited the RTI program after cycle 2, due to adequate progress made that placed them on or closer to grade level expectations
- 17 students in grades 5-8 exited the RTI program after cycle 2, due to adequate progress made that placed them on or closer to grade level expectations
- 8 students entered the program for cycle 3 from grades K-4
- 5 students entered the program for cycle 3 from grades 5-8
- ❖ Overall, students are making wonderful progress in Reading & Math through the LLI & Number Worlds program, progress is monitored frequently, and adjustments are made when students are not making satisfactory progress. We also have evidence to support that the programs are working well due to the number of students who have exited the program. Cycle 2 had a much higher number of students who made tremendous jumps in their reading in Math levels.
- * RTI Teachers check-in on students' progress who have exited the program during each cycle to ensure they are remaining on track.

Special Education:

- ❖ IEP Annual reviews for most school districts have been held or are scheduled to happen during the Spring. Most of our students have made progress towards meeting their annual goals and are slated to return to RCA next school year with the support of an IEP.
- Currently we have 30 students with IEPS between K-4th grade and 2 504s and 17 students with IEPs & 5 with 504s between 5th-8th grade for a total of 51 students.
- Of the 32 CST meetings held, we have 11 students in the evaluation process.
- ❖ IEP/504 students will be receiving testing accommodations for the state exams which are happening on 3/29 & 30 & 4/26 & 4/27

Discipline Report:

- ❖ Teachers continue to utilize Restorative Justice Practices at the start of classes daily as a connection tool to build positive, sustainable relationship with students. Such practices minimize negative classroom behaviors. ** Reminders have gone out to staff to continue practices. It has been strongly suggested that several of the utilized techniques are posted near the door so administration can observe the techniques that are in place in the classroom. This practice continues.
- ❖ I have purchased the book for staff: Pre-Referral Intervention Manual (4th edition) by Stephen McCarney. The book is a manual that is comprised of learning and behavioral problems in the educational environment with solutions for today's students. Staff can borrow the book as needed. Teachers have utilized several components from the book. This practice continues.
- Restorative Justice Practices remains reflected in Lesson Plans as a connective tool for academic and social emotional learning. This practice continues.
- Mrs. Kennedy, Elementary School Dean of Students, and I meet via Zoom every Wednesday morning to discuss various set agenda items such as parent communications, food drives, restorative justices visualized within the classrooms etc. Our latest discussion has been how to collaboratively discipline students when incidents on the buses occur. *** Recently, in the Middle School, I brought in two parents to assist in an incident. The parents were highly motivated to resolve the situation. The parents, along with their students were effective in resolution. They agreed to weekly check ins with each other and with me to see if their students were acting accordingly with bus rules and regulations. I email bus reports home along with phone calls. Disciplinary measures are utilized when needed.
- Teachers/TA's utilize Deans' List to record Parent Communication via phone, email, or text message. Administration strongly encourages phone communication. Several staff members were reminded to contact parents/guardians via phone instead of text or email.
 *** This continues to be a struggle for several staff members who continue to solely text or email parents. UPDATE: New staff members have been added to Deans' List. Teacher participation in Deans' List has increased. Parent phone calls have increased but still has a way to go.

- Lunch detentions continue. Several teachers have offered to give up their lunch periods to host lunch detentions.
- Suspensions for the month -2 Sixth Graders- ISS for play fighting which is fighting. 2 Seventh Graders-ISS for spraying aerosols around a classroom and in each other's face. 1-Seventh Grader-ISS for throwing a chair and threatening students. 1-Eighth Grader -ISS for degrading and disrespecting a teacher.
- ❖ Alternative Placement Program saw 4 students placed in alternative settings for 2 weeks due to negative behavior. Two sixth graders and two seventh graders. During their host class lunch period, the alternative placement students ate lunch and had chores around the building. Mrs. McGrath and I have been meeting with parents upon reentry to regular classroom setting to discuss behavior plans and goals. Behavior Plans will be signed daily by teachers at the end of each class. Rewards/Consequences are home based and are issued daily.
- ❖ At the time of this report, I have reviewed vaping tapes from April 6, 2022, that were pulled up. The tape shows several of our Middle School students vaping upon arriving off the bus and walking through the parking lot. I have contacted parents of several of the "vaping" students and are setting up meetings for Monday, April 25, 2022. Consequences will be determined. Origins of the vape and its content are paramount in determining consequences.
- Uniform policy is being reinforced. Lost and found extras add to fills in when needed. Calls are made when uniform infractions are found. Dean's List Blast was sent out to remind parents that we are a uniform school and what the uniform is to look like. Lunch detentions have been given for repeat offenders. ISS is an option for those students who are not complying.
- Several teachers (4) were asked to attend a 45 hour online in service Classroom Management Program with Nassau BOCES Center for Online Learning. The program began on February 17th, 2022 and will end May 17th, 2022. Each teacher can work on their coursework on their own time. The title of the class is Relationally Responsive Classroom Management-in-Service. Several teachers have not started their classes. UPDATE: One teacher has not started due to medical leave. One teacher is no longer on staff. I am currently attempting to retrieve a refund for those who did not attend.

- ❖ Community Service Program continues with the 8th grade class. Many students are working with teachers in school and parents have reached out to me regarding outside projects. Students are eager to read to the K-1-2-3rd grade students at 105 Pleasant Avenue.
- Deans Lunches need to continue. Many seventh graders have asked me to lunch in my office.
- Graduation committee continues to meet. Trips, prom, and ceremonies are discussed.
 Monies are being collected for trips, dances, and caps/gowns.
- Communication with administration is paramount. Dean communicates with Principal several times a day to discuss/review and creates strategies to make the middle school a safe and academically successful environment.
