**SCHOOL OPERATION Budget Update:** – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment presentation for 2022-23. Enrollment update presented reflected a student count of 70

5 as of March 28<sup>th</sup>. Ahead of last year's pace. Of that total 542 students re-registered. Incoming students registered 163. Of that total 83 were incoming Kindergarten. The budget is based on student count of 700.

The Approved Budget for fiscal 2022-23 presented as of March 31<sup>st</sup> reflected total budgeted full year (FY) revenue is \$14.2 million. YTD recognized \$10.2 million. Total budgeted (FY) direct expenses \$10.1 million. Spending YTD \$6.8 million. Total budgeted (FY) indirect expense is \$4.1 million. Spending YTD \$2.9 million. On target for spending 100% of budget.

# Middle School Report:

### **ACADEMICS:**

- ❖ Second round of informal observations will begin the week of March 20
- ❖ Parent/Teacher Conferences was on Thursday, March 16. One Hundred thirty-two parents attended. This was 48% of our student body population.
- ❖ Our dress down day civic fundraiser is a success. We were able to donate \$115 to the Holocaust Museum, \$150 to St. Jude Children's Hospital, and with our recent dress down day we raised enough money to donate \$230 toward Alzheimer's Research. Two-fifths of our next dress down day fundraiser will be donated to Breast Cancer research in honor of Women's History Month.
- ❖ Some of our eighth grade students are creating a collage to celebrate women of various cultures. Also, in honor of Women's History we will be hosting a Queen For A Day event on March 24<sup>th</sup> from 6 pm to 8 pm. Students will honor a special woman in their life.
- ❖ Our student Work Study Program is two weeks strong. Each week, Tuesday through Thursday, a few of eighth students assist Ms. Jackie, Mr. Harriott, and the receptionist in the admin building. Others, tutor 5<sup>th</sup>, 6<sup>th</sup>, and 7<sup>th</sup> grade students in math.
- ❖ In ELA, all grades are engaged in test prep every week on Tuesdays and Thursdays for 45-minute sessions.
  - 5th Grade continues the module with the essential question "How have athletes broken barriers during the historical era in which they live?" As they close the second unit, students are planning an opinion essay. They will utilize information and background knowledge of Jackie Robinson from, "Promises to Keep: How Jackie Robinson changed America," and other informational texts to plan an essay that states an opinion and has reasons that are supported by facts and details. They are also critiquing the writing of their peers with kind, helpful, and specific feedback.

6th Grade continues with the module topic of critical problems and design solutions. They have read the story of William Kamkwamba, a Malawian boy

- whose community endures a devastating drought and famine. William uses his
  creativity and inventiveness to build a windmill that ultimately saves his
  village. Our students used recyclable materials and the design thinking process
  to create and present their windmill prototypes. Their masterpieces are on
  display above the lockers on the 2nd floor.
- 7th Grade finalizes their in depth study of the Harlem Renaissance. Throughout this module, students have read poems and stories, listened to songs, and viewed visual and performing art from the Harlem Renaissance. For the culminating performance task, students will share these works with an audience in a Harlem Renaissance Museum. Students curate a set of texts, songs, and artwork connected by a theme from the Harlem Renaissance. They also curate a contemporary piece that they either found or made themselves. Students are creating both a written and oral presentation of their curator's statement, labels, and the works as part of their museum exhibit.
- 8th Grade students learned about a terrible time period in history, the Holocaust. They had an opportunity to hear and remember the voices of victims, survivors, and upstanders, Throughout the previous units students read the graphic novel Maus I, which tells the story of a Holocaust survivor. Based on the knowledge gained, students are creating a fictional profile of an imaginary upstander and writing a narrative of a fictional interview. For their performance task, students create graphic panels to represent a key moment of their narrative and write a reflection on the work they have created. Students present their panels to an audience and answer questions about their work.
- ❖ In Math, 5th Grade is currently working on using models and fraction equivalence to write fractions as decimals. 6th Grade is currently working on write, read and expressions in which letters stand for numbers. 7th Grade is currently working on solving two-step equations. 8th Grade is currently working on defining and identifying quadratic functions. Algebra 1 is currently working on divide rational expressions; rationalize the denominator.

#### RTI

- ❖ We are currently in our 3rd RTI cycle-which will conclude on May 12th.
- 10 students in grades 1-4 exited the RTI program after cycle 2, due to adequate progress made that placed them on or closer to grade level expectations.
- ❖ 8 students exited the RTI program in grades 5-8 after cycle 3, due to adequate progress made that placed them on or closer to grade level expectations.
- 12 students in kindergarten began RTI on February 27th, all are reading on an AA level.
- Overall, students are making wonderful progress in Reading & Math through the LLI & Number Worlds program, progress is monitored frequently, and adjustments are made when students are not making satisfactory progress. We also have evidence to support that the programs are working well due to the number of students who have exited the program. RTI Teachers check-in on students' progress who have exited the program during each cycle to ensure they are remaining on track.
- RTI teachers meet with Mrs. Johnson in to review student data after each cycle. Students' progress is discussed on an individual basis to determine needs for the next cycle. We also monitor the progress of students who have exited the program.

#### **Special Education:**

- IEP Annual reviews for most school districts have been held or are scheduled to happen during the early spring. Most of our students have made progress towards meeting their annual goals and are slated to return to RCA next school year with the support of an IEP.
- **❖** 3 IEPs were added in February.
- ❖ We currently have 8 students with evaluations pending and 14 students who have been referred for evaluations and are waiting on district registration to begin the process.
- The goal is to add at least 10-15 IEPs to our SWD population by June to increase our Special Education #s.
- ❖ We have a total of 54 students with IEPs or 504s Kindergarten through 8<sup>th</sup> grade. We have 34 students with IEPS between K-4th grade and 2 504s. There are 19 students with IEPs and 6 with 504s between 5th-8th grade.

IEP/504 students continue to receive testing accommodations for classroom exams as well as all state exams taking place this Spring.

### **ENL Report:**

The ENL students have begun review for the speaking, listening, reading and writing sections of the NYSESLAT Exam. The students continue to make progress with their English language skills. The middle school ENL team encouraged an 8<sup>th</sup> grade ENL student, Gandy Desir to enter a contest sponsored by the New York State Association for Bilingual Education. The student wrote an essay about being bilingual and biliterate. In the essay, he was asked to address the following questions:

- What does being bilingual and biliterate mean to you today and in the future?
- How does being bilingual and biliterate benefit your community?
- How does being bilingual and biliterate benefit our world?

We are proud to report that Gandy won first prize out of 121 participants statewide. He attended an awards luncheon on March 18<sup>th</sup> at the East Wind in Wading River, NY. He was asked to read his essay to the audience. He received a medal and a cash prize of \$150. He was accompanied by his parents and Mrs Kilstein/Mrs. Levy.

STRONG Youth Program for Grades 7 & 8: We continue to collaborate with the STRONG Youth Organization to implement three motivational speakers to visit our 7<sup>th</sup> and 8<sup>th</sup> grade

- classes throughout the course of the school year. Speakers will continue to take over Mr. Ellis's Social Studies classes for the day. Our first talk on November 15<sup>th</sup> was about Peer Pressure. Our second talk took place on February 15<sup>th</sup>. February's topic was, "The Cost of Peace: Three tips to deescalate conflicts". Violence often starts with a verbal or a social media dispute. In this conversation, students will learn the basic ingredients that escalate an argument into an incident, and how to prevent it. Students enjoyed both STRONG Talk's and were actively engaged. STRONG is scheduled to return for their third and final day on Wednesday, April 5.
- College Day: College Day has been scheduled for Friday, May 12. This will be a fair style event, with our visiting colleges set up in the gym. Students will come down by class to walk around the fair and receive information. Beforehand, students will participate in discussions about college and will be prepared with questions to ask. As of March 16, we have the following universities confirmed Nassau County Community College, Molloy University, and Long Island University.
- Career Day: Career Day has been scheduled for Friday May 19. The career day committee is working on bringing back presenters from last year and adding more. Letters will be going out to potential presenters on Monday, April 3.

#### **Discipline Report:**

- \* Restorative Modeling has been and will continue to be emulated in teachers' classrooms and in lesson plans.
- Classroom Values are posted in rooms along with Character Trait of the Month. Dean utilizes these traits with Restoratives Circles when necessary. February Trait: Self Discipline
- **Six Restorative Circles were held in my office. Four Fifth Grade-Two Six Grade Level Circles**
- Moments of Mindfulness meditation are scheduled every morning and afternoon to create a calm and community environment.
- Meditation Room has been established as an extra support room for those students who need to reflect on behaviors that are Tier 1 behaviors. An addition was added to the Meditation Reflection Room Sheet. Teachers must include why they are sending students to the room and call home as well as add the behaviors to Deans List for documentation purposes.
- Mrs. McGrath and I are creating a 7<sup>th</sup> grade strategy plan for discipline/SEL techniques.

- Working with several staff members to ensure that students who have disciplinary issues and IEP's/ 504 Plans are receiving district mandates. Ms. Johnson and Ms. Ms. McGrath are assisting in this process.
- ❖ Dean's List Shout Outs for the teachers who are utilizing the system Deans List, for calling home to notify parents of issues at school is in progress. This can be done weekly or monthly. Dress Down Passes for our top callers.
- Coaching teachers within the classroom setting regarding discipline structures. This task has already started with the seventh-grade team. Several visits have been made with input that will be discussed with the teachers, Ms. Roberts, and team coaches. All information will be documented for resourcing purposes. Teach Like a Champion is the text that is utilized for PD purposes. This includes teachers reading chapters and viewing text videos, having relevant professional discussion regarding observation and what is expected of the teaching/discipline process. Discipline this month is Procedures and Routines. Meeting with teachers for coaching purposes is set for specific dates.
- ❖ Teachers/TA's utilize Deans' List to record Parent Communication via phone, email, or text message. Administration strongly encourages phone communication. instead of text or email.
- ❖ The Uniform Policy is being enforced daily with several checks throughout the morning. Calls are made when an infraction is found. Dean's List messages are sent out to remind parents of infractions found within student body. As of now, we are reviewing the shoe policy regarding wearing Uggs which several of our upper grade students are wearing. A Deans' List blast was sent out to parents as guardians as well as individual parent emails to those students who are repeat offenders of the Ugg foot attire. \*\*\* Upper Middle School issues are Uggs and not wearing school shirts. iPads are also becoming technology concerns.
- The Community Service Program continues. Women's History Month and Ramadan are projects to be worked on.
- **Six parent meetings this month to discuss grades and disciplinary issues.**
- Dean is working with Ms. Kilstein for March Professional Development- Strategies for Dealing with Difficult Students.

- ❖ Working with Hempstead School District Bus Transport. Several IEP bus students that have behaving poorly on the Hempstead buses need to receive disciplinary actions that will support their IEP accommodations. \*\*\* Working with Mr. Longchamp, Ms. Roberts, Ms. Persad, Dean Di Tucci, and Ms. Johnson. To date, the Middle School is complying following any bus suspensions that have been issued.
- **❖** Alternative Placement continues with two eighth graders
- ❖ Dean will be taking several Restorative Circle Seminars beginning the end of January until the end of March. Each class is sponsored by SED and will result in a certificate of completion.
- Communication with administration is paramount. Dean communicates with Principal several times a day to discuss/review and creates strategies to make the middle school a safe and academically successful environment.
